Procurement at the WB

Corporate Responsibility at the World Bank Group



- If WB determines that any firm or individual has engaged in fraud and corruption in connection with a financed contract, the WB:
 - shall apply legal remedies as appropriate
 - may declare mis-procurement
 - shall suspend and/or debar the firm or individual
 - will not finance any new contract signed with the debarred or suspended firm or individual
- If a firm or an individual is debarred or suspended while a contract is ongoing:
 - The Borrower shall not sign an amendment including time extension without WB's review & no objection
 - WB will not finance any new amendment introducing a material change to an exiting contract signed with a debarred firm



Methodology for Assessing Procurement Systems



MAPS

- Provides a harmonized tool for assessing public procurement systems
- Universal tool guided by the principles value for money, transparency, fairness and good governance
- Aspirational standards serving as a guide toward reform
- Core assessment methodology, structure for country context analysis, refined indicator system for assessing the quality and performance of the system in terms of outcomes and results
- Indicator system (see figure)
- Each pillar has a number of indicators and sub-indicators, with a total of 14 indicators and 55 sub-indicators


Principales recomendaciones

- Amplia reforma normativa (regulación integral del régimen de contratación)
- Sistematizar de manera comprehensiva los distintos mecanismos de impugnación



GRAS: Evidence-Based / Scalable / Customizable

Innovation: System that identifies ~200 red-flags of potential fraud in public expenditures, which has been piloted at three levels of Government in Brazil (State/Municipal)



Preliminary Results and Expected Impact - Brazil

Preliminary Results

Identified over 420 firms that won bids against companies which have a high likelihood of being shell companies and reflecting potential bid rigging.

Identified 857 companies that won bidding processes against firms that have at least one partner in common.

450 firms whose partners are beneficiaries of the conditional cash transfer program *Bolsa Família*, and potentially strawmen.

Identified more than 500 firms who are owned by public servants working at the same governmental agency that has executed the contract



Expected Impact

Savings for identifying risks and improve public spending & More evidence to formulate cases against potential fraudulent firms

Use of Evidence for Decision-making & a potential "race to the top"

Positive signal to the market and companies to increase participation and competence in public bids

Increased Transparency of public expenditures and procurement processes

ProACT: Value Proposition

What ProACT offers: a unique harmonized database of procurement transactions

> Transactions-based indicators for comparative analysis and benchmarking of integrity and transparency of procurement

> Going deeper: Detailed and customized analysis of integrity and transparency of procurement (e.g. sectors, buyers, suppliers)

How it generates impact: global public good + tool for country engagement

Corruption risk diagnostics and benchmarking → Inform reforms


Screening tool for ex-post reviews: Anticorruption Agency, Supreme Audit Institution, CSOs, etc

Business development: capacity building for clients, ad-hoc diagnostics, GRAS, etc

Development objective

Strengthen accountability, transparency and integrity of public procurement

Supports and incentivizes the global adoption of digital eGP systems, open data, OCDS, and data analytics for anticorruption





Proact: Current Status: Indicators

ProACT provides access to eGP data on tenders and contracts that are publicly available to enable detailed analysis on integrity, transparency and competition in public procurement. It allows to analyze these dimensions at country level, or for specific buyers, suppliers, markets and contracts. The indicators measure practices and risks, they are not proof of misconduct.

Integrity

- Use of non-open procedure types
- Call for tenders publication
- Length of advertisement period
- Single bidder contract
- Length of decision period
- Benford's law
- Supplier's share of buyer spending on procurement
- Supplier is registered in a tax haven
- Delivery delay
- Cost overrun

Transparency



Additional Resources

PEFA, GTMI, GPPD



- <u>PEFA</u> assesses the institutional framework for key aspects of procurement management: monitoring of purchases, emphasis on open & competitive procedures, public access to information, and access to appeal and redress arrangements
- <u>GovTech Maturity Index (GTMI)</u> is a measure of digital transformation in the public sector across the globe, including the existence of an eGP portal, the eGP functionalities and whether eGP data are publicly available in open data (<u>OCDS) format</u>
- Global Public Procurement Database (GPPD) captures data about country procurement systems, regulatory framework, and status of eGP implementation at global level. GPPD identifies the Public Procurement Agency, the Central Purchasing Body, and relevant clauses, such as preferences for SMEs, preferences for domestic firms, and the use of MEAT (most economically advantageous tender) evaluation methods.
